DRY MANURE APPLICATION

Triune may also be sprayed independent of the manure application using a ground sprayer spraying a minimum of 40-50 gallons per acre. For best results apply within 48 hours of application of manure to the field. Use recommended application rate of 18oz per acre.

DIRECTIONS FOR USE WITH LIQUID MANURE/BIOSOLIDS

Add Triune directly to the manure. If the manure/biosolid has a high solid content add water before adding Triune. If manure/biosolids has a crust make sure to apply Triune below the crust to ensure maximum efficacy. If you do not add immediately to the pit then wait till pit is 20% full before applying Triune. When adding Triune pour entire container in one spot.
